Add Canine Good Citizen to your Dog's Title Record
(The Grandfathering Form)



Effective January 1, 2013, Canine Good Citizen® (CGC), became an official AKC® title. CGC can now appear on a dog's title record if the requirements are met.

Owners of dog's who earned the CGC award prior to January 1, 2013 are eligible to have CGC listed as a title on the dog's title record. Owners can apply to have CGC added to the dog's title record by submitting this application along with a \$20.00 title fee. If your application does not meet the requirements, your funds will be returned.

To have CGC recorded as a title that will appear on your dog's title record, the following requirements must be met:

_____ 1. Complete this application.

_____ 2. Your dog must have an AKC number, a PAL (formly ILP) number, or an AKC Canine Partners number. (All dogs, including mixed breeds, can get an AKC number in on of these categories). AKC attaches titles to your dog's title record.

_____ 3. Enclose the \$20.00 title recording fee.

_____ 4. **Optional.** Attach a copy of your CGC certificate if you have it. This is not required, however, the copy, along with the information on this form, will assist us in locating information about your CGC test and will expedite the processing of your application. If you cannot find your CGC certificate, it is not necessary to purchase a duplicate for this application. You will receive a new, updated certificate when your application is processed.
